### P16.40 Apologies

Apologies were received and accepted from Councillors M Heaslip, A McGuckin and V Morgan

### P16.41 Declarations of Interest

## P16.42 Exclusion of Press and Public (Public Bodies Admission to Meetings Act 1960) No issues were raised.

### P16.43 Minutes of the last meeting

The committee received the minutes of the meeting on 7 November 2016 and affirmed them as a true record.

#### P16.44 National Grid Response

The clerk provided the committee with a plan of the proposed National Grid pylons. This included new pylon sites and those that were being replaced or removed. The clerk drew the committee's attention to a proposed pylon site adjacent to the River Derwent. There was concern about how this construction would affect or could be affected by flooding. The clerk reported that the consultation information provided by National Grid contains the engineering principles of the pylons, but not the possible impact from the construction process. The lack of this information provided in the consultation restricts the Council's ability to comment on the proposal fully.

**Resolved:** For the clerk to finalise a consultation response in liaison with Councillors P McHarry and M Rollo.

### P16.45 Footway Solway Road/ Annie Pit Lane

Councillor J Holliday declared an interest for this item and abstained from discussion. The clerk gave an overview of the proposed widening at Solway Road/ Annie Pit Lane to accommodate a shared footpath. He explained that Cumbria County Council don't have any plans, at present, to extend the shared footpath beyond Harrington Road. Councillors discussed the scope of the footpath and it was noted that this proposal doesn't lead to a cycle route nor is it a route to school. A councillor suggested that the purpose could be to promote cycling to work and to remove traffic from the road. There was a discussion about how the pathway would be signposted and the overall aim of the proposal.

**Resolved:** To provide feedback, to Cumbria County Council, highlighting concerns about signposting and the location of the cycle path as part of a strategic cycle network.
