#### P18.46 Minutes of the last meeting

The Committee received the minutes of the meeting on 4 November 2018 and affirmed them as a true record.

### P18.47 Representation to the Development Panel

The Committee considered making a representation to the Development Panel on 11 December 2018 in relation to 2/2017/0246, an application for 115 residential dwellings on land east of Main Road, High Harrington. The Committee noted that it had recommended the initial application be rejected. They went on to consider whether the application in its latest form had met any of the concerns the committee had back in 2017. There was still concern about the scale of the development, and the committee was particularly unimpressed by the emergency access road which had been added to the plans. This didn't meet the criteria for an emergency access which would prevent a blockage on the one existing access road. There was also concern about the schools provision, which seemed wholly inadequate, serving to add to traffic, rather than reduce it.

The junction seemed have been made even more complex by the addition of the emergency access road. Cycling provision had also not been addressed and in all it appeared to lack imagination.

<u>Resolved:</u> To confirm a presence at the Development Panel for the Chair to give the council's view. The Clerk and the Chair would meet prior to the meeting to confirm the action points, and these would be shared with the other members of the committee prior to the meeting on
