## **6. Bus Shelter**

To consider an 'in principle' response to a proposal to install a bus shelter on Derwent Drive.

### **Background**

County Cllr Alan Barry is proposing to use some of his member's discretionary budget to erect a bus shelter for passengers on the northbound carriageway on Derwent Drive (opposite Morrisons). County Council policy on bus shelters is to seek local adoption of bus shelters once installed. It is possible that the installation would be accompanied by a small dowry in return for adoption by the town council. The council may also liaise with the county over the design of the installation.

The council has received requests to support a bus shelter here in the past. The shelter would be for people using the 50 and 51 routes (circular from Westfield/Moorclose).

### **Response required**

The committee should indicate whether they would support such a development and make a recommendation to Full Council accordingly.

### **Part Two**
