5. HGV Traffic on the A596

To consider Aspatria Town Council's recommendation to obtain an appraisal of the timber traffic on the A596.

Background

Aspatria Town Council has recently discussed concerns about the noise, vibration and health impacts of an increased number of HGVs travelling on the A596. Councillors believe that there is a case for the HGVs to travel along the A595 and attempts should be made to look into the infrastructure to support this. Aspatria Town Council has written to the Parish and Town Councils, covering this route, to ask for their support for an appraisal/feasibility study of timber traffic on the A596.
